- Form 21 (Sale Certificate)
- Form 22 (Road Worthiness Certificate)

- PAN Card (for high-value vehicles)

### **For Transfer of Ownership:**

- Form 29 & Form 30
- Original RC
- Insurance copy
- Pollution Under Control (PUC) certificate
- Address proof of buyer
- Passport-size photographs

### **For Duplicate RC:**

- FIR copy (if lost)
- Form 26
- Insurance copy
- PUC certificate

Accurate submission helps prevent rejections or repeated visits.
